Honey is a food, usually found in a viscous liquid state and sugary, which is produced by bees from the nectar collected of flowers and processed by the digestive enzymes of these insects, being stored in combs in their hives to serve them as food.

It has nutritious and therapeutic properties that bring several health benefits. It is rich in antioxidants, vitamins and minerals

O Wildflower honey is obtained by collecting the nectar of several species of flowers and this gives it a characteristic flavor and odor, more accentuated than Orange Flowers honey and less marked than Eucalyptus honey. Its color varies from yellow to brown.
